THE PURPOSE IS TO DEVELOP AND FOSTER TRUSTING CHRISTIAN RELATIONSHIPS WITH CHILDREN OF INMATES BY ENGAGING THEM IN A FUN, WORSHIPFUL AND A SAFE ENVIRONMENT. THE LEADERSHIP TRAINING ACADEMY (LTA) PORTION OF CAMP HOPE IS BY INVITATION FOR THOSE CAMPERS
